Mae gan Gyngor Sir Ynys Môn y strwythur canlynol mewn lle ar gyfer dysgwyr sy'n dymuno prynu tocyn bws er eu bod yn byw llai na'r terfyn presennol o 3 milltir oddi wrth eu hysgol agosaf, neu wedi penderfynu dychwelyd i astudio ym mlwyddyn 12 neu 13.

The Isle of Anglesey County Council have the following fee structure in place for pupils who wish to purchase a bus pass although they live less than the current limit of 3 miles from their nearest school, or have decided to return to school to study in year 12 and 13.

The council also have a vacant seat scheme where pupils who attend a school outside of their catchment area can pay for a vacant seat if there is one available:

Rydym wedi sicrhau bod nifer o ffyrdd hyblyg o dalu. Mae'r manylion i'w gweld ar y daflen ynghlwm.

We have a number of convenient ways to pay. Please see the attached sheet for details.

Nid oes gan yr Awdurdod gynlluniau i gyflwyno cynllun sydd yn gwahaniaethu rhwng disgyblion o ran nifer y teithiau maent yn cymryd. Gan dalu am docyn mae hyn yn sicrhau sedd i'r disgybl ar y bws pryd bynnag mae o neu hi'n teithio. Ni thelir ad-daliadau heblaw eich bod wedi symud tŷ i fyw mwy na 3 milltir o'r ysgol dalgylch.

The Authority does not have plans to present a scheme that differentiates between pupils according to the number of journeys that they take. In paying for a pass this ensures a seat for the pupil on the bus whenever he or she travels. No refunds will be paid except for those who move house to live more than 3 miles from their catchment area school.

Regular checks will be undertaken as from September 2019 to ensure that all learners travelling on school transport have an appropriate bus pass.


